

TEN YEAR COMMERCIAL WARRANTY FOR MANNINGTON QUANTUM NYLON™ WITH SAFEGUARD SR™ STAIN RESISTANT TECHNOLOGY

Mannington Quantum Nylon™ is Mannington Commercial's Branded Nylon.

Mannington Commercial, a business unit of Mannington Mills, Inc., warrants that its carpet products made with Mannington Quantum Nylon™ and treated with SafeGuard SR™ Stain Resistant Technology will resist staining for a period of ten (10) years from the date of original purchase.

The Following is the Ten Year Commercial Warranty issued by Mannington Commercial for our Mannington Quantum Nylon™ with SafeGuard SR™ Stain Resistant Technology:

The warranty begins on the date that the carpeting is purchased and is further limited to the period of time the carpet is owned and maintained by the original end-use purchaser. The date of purchase for purposes of this warranty and any warranty related claim shall only be evidenced on the original Mannington or dealer invoice. The carpet must be installed in accordance with the applicable Mannington Commercial installation guidelines and specifications. The carpet must be maintained in accordance with the applicable Mannington Commercial maintenance recommendations from the date of original installation and throughout the duration of the period of time the carpet is owned by the original end-use purchaser.

FIBER STAIN WARRANTY

1. Mannington Commercial warrants that for ten (10) years from the date of original purchase, this carpet, made exclusively with Mannington Quantum Nylon™ with SafeGuard SR™ Stain Resistant Technology will resist permanent stains caused by spills of all acid based substances.
2. In order to make a claim under this warranty, the owner must have attempted to remove the acid based stain within three (3) days after occurrence of the spill, USING ONLY THOSE CLEANING AGENTS AND PROCEDURES RECOMMENDED BY MANNINGTON COMMERCIAL AND MUST NOTIFY MANNINGTON COMMERCIAL IMMEDIATELY IF STAIN REMOVAL IS NOT SUCCESSFUL. If the stain is removed as guaranteed, all stain removal costs will be the responsibility of the owner.
3. In addition the owner must permit a Mannington representative access to the installed carpet in order to attempt to remove the stain.

EXCLUSIONS

This warranty does not cover:

- Stains caused by spills of all non-acid based substances
- Color loss due to ozone or light fading
- Damage resulting from abnormal use, conditions such as water, storm or flood damage, or damage from use of improper cleaning agents
- Damage from overall wear

CONDITIONS

This warranty shall not be effective unless the following conditions are satisfied:

1. The warranty applies only to indoor commercial installations where the carpet has been installed and maintained in accordance with Mannington's recommended guidelines.
2. Carpet cleaning and spot cleaning procedures recommended by Mannington Commercial, as set forth in Mannington Commercial's recommended cleaning brochure, must be followed.
3. The customer must provide Mannington with reasonable cooperation in the performance of its obligations under this warranty.
4. The customer must provide Mannington with proof of purchase as evidenced on the invoice showing the original installation date, in order to initiate a warranty claim.
5. The attached Warranty Registration Form must be completed, signed by all parties, and returned to Mannington within 90 days of installation.

This warranty only covers the original end-use purchaser of the Mannington carpet and at the original carpet installation site. This warranty is not transferable.

The foregoing warranty is exclusive and in lieu of all implied warranties, including implied warranties of merchantability and fitness for a particular purpose, and there are no implied warranties, including implied warranties of merchantability and fitness for a particular purpose, extending beyond the duration of this warranty. Except for the specific remedies set forth below, Mannington shall have no liability for any damages, whether direct, incidental or consequential (including but not limited to, damages for lost profits), resulting from the installation, use, performance, maintenance, repair or replacement of this Mannington carpet.

This warranty gives you the specific legal rights, and you may also have other rights, which vary, by state. The terms of, and remedies available under, this warranty can only be modified or extended if expressly authorized, in writing, by an authorized representative of Mannington. MAKING CLAIMS

REMEDIES

Mannington, at its option, may designate a representative to inspect the carpet and/or have the carpet tested by the fiber manufacturer or an independent testing firm. If inspection or independent testing reveal that the carpet has not performed as warranted above, then Mannington will, at its option, (i) repair the affected carpet, (ii) install new carpet of comparable value to replace the carpet in the affected area, as determined by Mannington in its reasonable discretion, or (iii) compensate the owner for the actual replacement cost of the yardage contained in the affected area, up to 100 times the size of the stain. "Replacement cost" means the cost of (i) replacement of Mannington carpet of comparable value in a yardage sufficient to cover the affected area as determined by Mannington in its reasonable discretion, (ii) freight to the installation site, (iii) materials necessary for installation, and (iv) installation of the replacement carpet. All other costs, including the cost of removing equipment, furnishings, partitions or anything else installed or placed over the carpet, are the responsibility of the owner.

These are your exclusive remedies under the limited warranty set forth above.
